

October 23, 2018

The Board of Supervisors met at 9:00 o'clock A.M. with Eric Skoog, Chairman presiding. All members were present.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

A motion was made by Ulmer, seconded by Schultz to approve the plans and specifications for Bridge Replacement Project BROS-SWAP-C024(119)-SE-24 Bridge Replacement on B Ave over Porter Creek.

Motion passed unanimously.

At 10:00 o'clock A.M., as advertised, a motion was made by Skoog, seconded by Muhlbauer to open the public hearing regarding the final order to the following roadway vacations: a portion of L Ave. between 160th St. and Hwy 141, a portion of S Ave. lying west of Dane Ridge Road, a portion of P Ave. lying east of 100th St and a portion of S Ave. lying west of 180th St.

Motion was approved unanimously. Various members of the public were present to get clarification on certain points of the resolution. There were no written objections. At 10:25 o'clock A.M., a motion was made by Blum, seconded by Muhlbauer to close the public hearing. Motion was passed unanimously.

A motion was made by Ulmer, seconded by Schultz to approve the following resolution:

Resolution No. 2018 - 22
(Final Order on Road Vacations)

WHEREAS, This being the date and time set for the hearing on the proposed vacation and closure of Crawford County Secondary Roads described as follows:

Willow Township

A portion of Road No. 120 between Sections 18 & 19, T83N, R41W, Willow Township (aka P Ave. East of 100th St.) described as follows: Beginning at a point twenty (20) feet East of the N $\frac{1}{4}$ Corner of Section 19, T83N, R41W and running thence West along the centerline of a sixty-six (66) foot wide road one-half mile to a point thirty-three (33) feet East of the NW Corner of Section 19, T83N, R41W; and also vacate all of Road No. 977 located along the North Line of Section 19, T83N, R41W.

Union Township

A portion of Road No. 232 commencing at the east boundary line of Northeast quarter of the Northwest quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section 5, T82N, R40W, Union Township thence easterly 2,100 feet along the North line of said Section 5, T82N, R40W. (aka S Ave. between Dane Ridge Rd. and 1790 S Ave.)

Paradise Township

All of a road established and recorded in Crawford County Supervisor's Minute Book "Y", Page 396 on August 6, 1964 described as follows: South line of the West Half of the Southeast Quarter (W $\frac{1}{2}$ SE $\frac{1}{4}$) of Section Thirty-one (31), Paradise Township, Crawford County, Iowa, beginning at the Southwest (SW) corner of the West Half of the Southeast Quarter (W $\frac{1}{2}$ SE $\frac{1}{4}$) of Section Thirty-one (31), Township Eighty-three (83) North, Range Forty (40), West, Paradise Township, Crawford County, Iowa, and running thence east on the south line of the West Half of the Southeast Quarter (W $\frac{1}{2}$ SE $\frac{1}{4}$) of said Section Thirty-one (31), Township Eighty-three (83) North, Range Forty (40), West, to the Southeast (SE) corner of said West Half of the Southeast Quarter (W $\frac{1}{2}$, SE $\frac{1}{4}$ of Section Thirty-one (31), Township Eighty-three (83) North, Range Forty (40), West, Paradise Township, Crawford County, Iowa. (aka S Ave. West of Dane Ridge Rd.)

Hanover Township

A portion of Road No. 119 between Sections 30 & 31 T84N, R40W, Hanover Township (aka L Ave. between 160th St. & 1649 L Ave.) described as follows: Beginning at a point 350 feet West of the North $\frac{1}{4}$ corner of Section 31, T84N, R40W thence West to a point 200 feet East of the NW Corner of Section 31, T84N, R40W.

WHEREAS, no objections have been received, either in writing or by persons present.

As a condition of vacating P Ave. East of 100th St. (Willow Township), Crawford County shall furnish and place a 48" corrugated metal pipe culvert to provide crossing over drainage area in SW $\frac{1}{4}$ Section 18 Willow Township. Crawford County shall claim no responsibility for the drainage culvert after installation. Crawford County shall also widen an entrance sufficient to facilitate semi-tractor trailer access, said entrance is located along the west line of Section 18 approximately 1750 feet north of the SW Corner of Section 18.

As a condition of vacating a portion of L Ave. between 160th St and 1649 L Ave. Crawford County agrees to maintain all portions of the remaining roadway surfaces of L Ave. between 160th St and 1649 L Ave. as a Level A Area Surface road (i.e. gravel road).

Crawford County agrees to establish the respective section lines in the vacated portions of all aforementioned roadways upon request of the landowner.

NOW THEREFORE BE IT RESOLVED by the Crawford County Board of Supervisors that the subject roads be ordered vacated and closed.

Voting Aye: Blum, Muhlbauer, Schultz, Ulmer, and Skoog. Voting Nay: None. Motion passed unanimously.

A motion was made by Ulmer, seconded by Blum to approve the Crime Bond Policy Renewal.

Motion was passed unanimously.

On motion, duly seconded, the Board adjourned at 10:37 o'clock A.M.
