RESOLUTION TO PAY BACK INTER-FUND TEMPORARY OPERATING LOAN

WHEREAS, an inter-fund operating loan for \$86,439.90 was made from the HCCMS Family Planning Fund #0040 to the General Basic Fund #0001 per resolution #2021-35 approved June 29, 2021, in accordance with Section 331:432 of the Code of Iowa.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF CRAWFORD COUNTY, IOWA, AS FOLLOWS:

Section 1. The temporary loan of \$86,439.90 is ordered to be transferred from the General Basic Fund #0001 back into the HCCMS Family Planning Fund #0040.

Section 2. The Auditor is directed to correct her books accordingly and to notify the Treasurer of this operating loan repayment, accompanying the notification with a copy of this resolution and the record of its adoption.
