

September 27, 2022

The Board of Supervisors met at 9:00 o'clock A.M. with Kyle Schultz, chairman presiding. Members present were Heiden, Rosburg, Vogt, Schultz, and Skoog.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board recognized the resignation/change of status of Alyssa Willenborg, Clinical Manager, at Public Health.

The Board approved a wage change for Troy Rosburg, Maintenance Employee III, Engineer's Department.

A motion was made by Rosburg, seconded by Skoog to approve Subgrade Stabilization and Seal Coat Proposal from Manatt's, Inc. related to work on a 4500 foot long section of O'Banion Rd lying west of the intersection with Nelson Park Road.

Motion passed unanimously.

A motion was made by Skoog, seconded by Vogt to approve 2024 International single axle dump truck from Cornhusker Truck in the amount of \$107,225.00. Contingent FY 2024 budget approval.

Motion passed unanimously.

A motion was made by Vogt, seconded by Heiden to approve Everest American Dump Body, for single axle dump truck, from Macqueen Equipment in the amount of \$51,531.00. Contingent FY 2024 budget approval.

Motion passed unanimously.

A motion was made by Heiden, seconded by Vogt to approve Iowa DOT Federal-aid Agreement for a County Highway Bridge Program Project – BRS-C024(129)—60-24, L51 Bridge over the Soldier River.

Motion passed unanimously.

A discussion was made with the Board about possibly sharing cost of Attorney with Shelby County pertaining to the Carbonic Pipeline.

No action was taken at this time.

A motion was made by Rosburg, seconded by Heiden to approve assigning CH Tax Certificate Parcel 1311103007 to Jose Montiel, forgive taxes and interest, Jose is to pay assignment fee and current taxes.

A motion was made by Rosburg, seconded by Heiden to approve assigning CH Tax Certificate Parcel 0420400005 to Glen Gustafson, forgive taxes and interest, Glen is to pay assignment fee and current taxes.

A motion was made by Vogt, seconded by Skoog to approve of setting the date and time for a Public Hearing for Budget Amendment for FY 2023 for October 18, 2022, at 10:00 o'clock A.M. in the Board of Supervisors Room.

Motion was passed unanimously.

A motion was made Vogt, seconded by Rosburg to approve Central Iowa Juvenile Detention Center Audit Report FY 2021.

Motion was passed unanimously.

The Board canvassed the 2nd Tiers of votes cast in the Ar-We-Va Special Election held on September 13, 2022. The Board also canvassed the 2nd Tier votes cast in the Charter Oak-Ute Special Election held on September 13, 2022. Copies of the canvass and abstracts are available in the Auditor's Office.

During Citizen's Input – Brad Hanson, Denison City Manager, spoke to the Board about cost sharing Planning Grant for shared use paths – Reconnecting Communities.

On motion duly seconded the Board adjourned at 11:16 o'clock A.M.
