The Board of Supervisors met at 9:00 o'clock A.M. with Jean Heiden, chair presiding. Members present were Schultz, Dozark, Heiden, Muhlbauer, and Rosburg.

Minutes of the previous meeting were read and approved.

The Board approved the resignation of A. Lyle Miller, Trustee of Nishnabotna Township.

The Board approved the change of wage for Greg Miller, Crawford County Emergency Management Coordinator.

A motion was made by Muhlbauer, seconded by Schultz to approve the appointment of Tony Lile as Nishnabotna Township Trustee to fill a vacancy until the next eligible election.

Motion was passed unanimously.

A motion was made by Muhlbauer, seconded by Dozark to approve the contract renewal for Paul Assman, Crawford County Engineer, for one year \$150,000.00.

A motion was made by Schultz, seconded by Dozark to approve the Collective Bargaining Agreement July 1, 2024 – June 30, 2027, wage schedules and increase in clothing allowance for Crawford County Landfill Bargaining Unit Employees.
