A motion was made by Schultz, seconded by Rosburg to set the time, date and location for a Public Hearing regarding the Budget Amendment FY 2023/2024 for April 16, 2024, at 10:00 a.m. in the Board of Supervisor's Board Room on the Second Floor of the Courthouse.

Motion was passed unanimously.

A motion was made by Muhlbauer, seconded by Dozark to approve a Public Hearing for Budget FY 2025 for April 23, 2024, at 10:00 a.m. in the Board of Supervisor's Board Room on the Second Floor of the Courthouse.

Motion was passed unanimously.

A motion was made by Dozark, seconded by Rosburg to approve the appointment of Karla Dorale as Charter Oak Township Trustee to fill a vacancy until the next eligible election.

Motion was passed unanimously.

A motion was made by Schultz, seconded by Dozark to proclaim April 2024 as Child Abuse Prevention Month in Crawford County.

Motion was passed unanimously.

On motion duly seconded the Board adjourned at 11:42 o'clock A.M.
