WHEREAS, The Crawford County Board of Supervisors recognizes the need to incorporate safety features in pavement resurfacing projects, and

WHEREAS, Transportation Safety Improvement Program (TSIP) Funds are annually made available to qualifying local projects in amounts not to exceed \$500,000 to facilitate the incorporation of said safety features, and

WHEREAS, application for said funds must be submitted to the Iowa Department of Transportation for review and approval, and

WHERAS, as part of the application procedure, a commitment of funds and a commitment to maintain the facility for the useful life of the improvement must be made by the applicant,

THEREFORE, BE IT HEREBY RESOLVED, that the Board of Supervisors of Crawford County, Iowa, as part of the application for TSIP funds, resolve to commit to the additional funds needed above and beyond those granted to Crawford County by the Transportation Safety Improvement Program and to supply the Construction and Engineering cost for the County Road E59 Payment Resurfacing and Widening Project (extending from the East Corporate Limits of Dow City east to its intersection with U.S. Hwy 59) from existing county funding and also resolve to maintain the facility for the useful life of the improvement.
