Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board recognized the following Underground Utility Permits:

No. 19-19 – Western Iowa Power Coop – installation of an underground electric cable crossing 390th St at a point located 2160 feet north of the intersection of 390th St and Co. Rd. E16.

No. 19-20 – Western Iowa Power Coop – installation of an underground electric cable crossing 200th at a point located 600 feet south of the intersection of 200th St and IA Hwy 141.

No. 19-21 – NIPCO – installation of an underground fiber cable along E Ave commencing at the intersection of 240th St. thence east 266 feet.

No. 19-22 – West Central Iowa Rural Water Assn. – installation of a 2" water service line crossing K Ave at a point located 65 feet west of the intersection with 200th St.

No. 19-23 – West Central Iowa Rural Water Assn. – installation of a 2" water service line crossing Co Rd E16 (aka C Ave) at a point located 30 feet east of the centerline of the driveway for 3215 C Ave.

No. 19-24 – Western Iowa Power Coop – installation of an underground electrical cable along 200th St. commencing at the entrance to 2029 200th St thence north along 200th St 300 feet.

No. 19-25 – Western Iowa Power Coop – installation of an underground electric cable along 350th St. commencing at the intersection of 350th St. and Co Rd M55 thence north 650 feet along the center line of 350th St.

No. 19-26 – Western Iowa Power Coop – installation of an underground electric cable along R Ave commencing at 3426 R Ave thence east 1055 feet to 3443 R Ave.
