Minutes of the previous meeting were read and approved.

The board recognized the resignations of Trent Nelson, Lucas Aroujo, and Ashton Blum, Seasonal Park Attendants for the Conservation Department. The board also recognized the resignation of Natalee Schwarte, Naturalist Intern from the Conservation Department.

The Board discussed lots in Boyer and possible ordinance needed for nuisance properties.

The Board met with Carey Kersey from Environmental Health to discuss a possible tanning bed inspection ordinance.

NOW, THEREFORE, be it resolved by the Board of Supervisors of Crawford County, Iowa that

The sum of Three Hundred Thousand Dollars (\$300,000) is hereby transferred from the General Basic Fund #0001 into the General Supplemental Fund #0002 and

The sum of One Hundred Fifty Thousand Dollars (\$150,000) is hereby transferred from the Rural Basic Fund #0011 into the Rural Supplemental Fund #0012.

A motion was made by Muhlbauer, seconded by Skoog to proclaim September 2019 as Voter Registration Month.

Motion was passed unanimously.

A motion was made by Blum, seconded by Muhlbauer to approve the Rural Dwelling Tax Exemption Application for a New "Shouse" at 1960 280<sup>th</sup> Street, owned by David and Cindy Gray.

Motion was passed unanimously.

A motion was made by Vogt, seconded by Muhlbauer to approve the abatement of taxes on Parcel #13-11-376-013.

A motion was made by Blum, seconded by Skoog to approve the abatement of taxes on Parcel #04-29-200-006.

Motion was passed unanimously.
