RESOLUTION REGARDING THE 2020 CRAWFORD COUNTY TAX SALE AS IMPACTED BY COVID-19

A resolution by Crawford County to recognize the status of the 2020 annual property tax sale.

WHEREAS, Governor Kim Reynolds has issued Proclamations of Disaster Emergency commencing March 17, 2020 and extending through August 23, 2020 at 11:59 p.m. unless sooner terminated or extended as of the time of the resolution; and WHEREAS, these Proclamations by Governor Reynolds have delayed the annual property tax sale authorized by Iowa Code Chapter 446; and

WHEREAS, Section Ninety-eight of the Proclamation of the Disaster Emergency by Governor Reynolds dated July 24, 2020, provided in part that "the county treasurer shall have the sole discretion if any tax sale in a county that has not held in June can be held in a particular month or must be further delayed."

NOW, THEREFORE BE IT RESOLVED, Crawford County recognizes the decision by the Treasurer of Crawford County, Sheri Neddermeyer, to exercise the authority of her office to cancel the property tax sale for 2020.

A Board discussed hiring Ray Freeman & Associates as a Consultant for the LMR Communication System. No action was taken at this time.

WHEREAS, the Crawford County Board of Supervisors has received a notice of preliminary decision from the Iowa Department of Natural Resources to issue a construction permit for Melvin Neddermeyer, IDNR Facility ID# 57985; WHEREAS, the Board has the right to contest the issuance of a permit pursuant to Iowa Code section 459.304 and Iowa Administrative Code 567-65.10(7) no later than 14 days after receipt of the DNR's notice of preliminary decision to issue the permit;

RESOLVED after proper public notice and full discussion of this matter, and upon no objections being voiced against the issuance of the permit, the Board hereby irrevocable and unconditionally waives its right to appeal under Iowa law so that Melvin and June Neddermeyer may receive their DNR construction permit and proceed with construction.
