APPROVAL OF FY2022 MAXIMUM PROPERTY TAX DOLLARS

WHEREAS, the Crawford County Board of Supervisors have considered the proposed FY2022 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county web site and/or social media account if applicable,

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on March 3, 2021 at 10am

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Crawford County that the maximum property tax dollars for General County Services and rural County Services for FY2022 shall not exceed the following:

General County Services - \$5,742,386, an increase of 2.70% from the prior year.

Rural County Services - \$3,451,015, an increase of 2.67% from the prior year.
