The Board of Supervisors met at 9:00 o'clock A.M. with Ty Rosburg, chairman presiding. Members present were Schultz, Dozark, Rosburg, Muhlbauer, and Heiden.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

A motion was made by Heiden, seconded by Muhlbauer to approve the Award HMA Resurfacing Project FM-C024(130)—55-24, County Road M55 from O Ave to North of I Ave, to INROADS, LLC in the amount of \$2,498,344.32, Engineers estimate \$2,160,825.50.

Motion was passed unanimously.

A motion was made by Heiden, seconded by Dozark to approve the appointment of Linda Muhlbauer to the Region XII COG Policy Council for a one-year term ending December 31, 2023.

Voting Aye was Schultz, Dozark, Rosburg, and Heiden. Abstaining Due to Conflict of Interest: Muhlbauer. Motion was passed.

A motion was made by Heiden, seconded by Dozark to approve the hiring of Jason Blunk as the Weed Commissioner at the pay rate of \$14.45 per hour.

Motion was passed unanimously.

A discussion was made by the Board about the Tax Credit for Volunteer Emergency Service Providers. No action was taken at this time.

A discussion was made by the Board with Brittney Ruba, FEH Design via Zoom about the City Center remodel design. No action was taken at this time.

A motion was made by Muhlbauer, seconded by Heiden to authorize the County Attorney's Office to consult with an outside counsel on a "County Ordinance – Soil Restoration."

A discussion with the Board for an initial exchange of proposals between Crawford County Sheriff and Teamsters Local #554.

During Citizen Input there were citizens here to express their concerns about the economic impact, possible ordinances, and safety.

Colby DeWitt and Brittney Rockwell from Senator Ernst Office stopped in to introduce themselves.
