The Board of Supervisors met at 9:00 o'clock A.M. with Ty Rosburg, chairman presiding. Members present were Schultz, Heiden, Rosburg, Dozark and Muhlbauer.

Minutes of the previous meetings were read and approved.

A motion was made by Muhlbauer, seconded by Heiden to approve maintenance gravel purchase agreements with Stratford Gravel for 2024 delivery. Cates Pit – 50,000 ton with 15% limestone @ \$8.03/ton and Sparks Pit – 25,000 ton @ \$7.50/ton.

Motion was passed unanimously.

A motion was made by Schultz, seconded by Dozark to approve the 2023 Dust Control Agreements with Jerico Services and Heffron Services, Inc.

Motion was passed unanimously.

A motion was made by Heiden, seconded by Muhlbauer to approve the contract, bonds, and certificates of insurance for HMA Resurfacing Project: FM-C024(130)—55-24, County Road M55 from O Ave to north of I Ave to INROADS, LLC in the amount of \$2,498,344.32.

RESOLUTION #2023-16

APPROVAL OF FY2024 MAXIMUM PROPERTY TAX DOLLARS

WHEREAS, the Crawford County Board of Supervisors have considered the proposed FY2024 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county web site and/or social media account if applicable,

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on March 7, 2023 at 10:00 a.m.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Crawford County that the maximum property tax dollars for General County Services and rural County Services for FY2022 shall not exceed the following:

General County Services - \$6,341,244, an increase of 1.89% from the prior year.

Rural County Services - \$3,728,784, an increase of 1.72% from the prior year.

Voting Aye: Heiden, Rosburg, Schultz, Dozark and Muhlbauer. Motion passed unanimously.

A motion was made by Heiden, seconded by Dozark to approve increasing disability insurance benefit amount to \$175,000.

Motion was passed unanimously.

A motion was made by Heiden, seconded by Schultz to approve the Tax Abatement for 3 years 100% for Parcel #1710128001, 402-517 E
Fulton St, Dow City, Nick Ohl – Mini Storage.

Motion was passed unanimously.

The Board held Budget Works Session with Chuck Ettleman.

On motion duly seconded the Board adjourned at 12:24 o'clock P.M.
