The Board had a discussion with Jessica Garcia, City Manager of Denison about splitting the bills with the City of Denison for the Wellness Center.

A motion was made by Dozark, seconded by Rosburg to approve \$83,333 from the County for the DMU proposal to go towards the Wellness Center. No action was taken at this time.

A motion was made by Dozark, seconded by Rosburg to amend the previous motion regarding the DMU proposal to include a contingency of the approval of the CAT Grant.

Motion was passed unanimously.

A motion was made by Dozark, seconded by Rosburg to approve \$83,333 from the County for the DMU proposal to include a contingent approval of the CAT Grant to go towards the Wellness Center.
