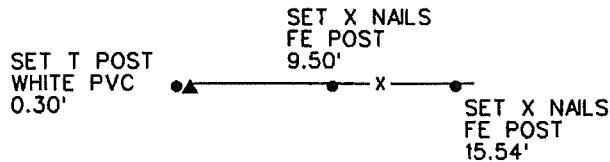
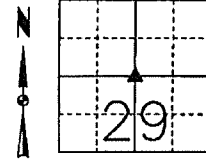
OVERALL COUNTY MONUMENT MAP DOES NOT INDICATE ANY CONCRETE MONUMENT BEING SET. NO INDIVIDUAL SECTION CORNER TIE FOUND EITHER. BUT IN REVIEW OF THE COUNTY ENGINEER'S TIE FOR THE N1/4 OF SEC 29, IT SEEMS TO REFER TO THE CENTER OF SECTION. AN INTERSECTION OF THE N1/4 S1/4 AND THE E1/4 W1/4 PLACES THE POTENTIAL CORNER VERY WELL AND VERY NEAR TO REMNANTS OF AN OLD CORNER POST. THE AREA WAS DUG UP AND PROBED IN THE HOPES OF FINDING SOME TYPE OF MONUMENT BUT NOTHING WAS FOUND. SET 1/2" REBAR WITH YPC 17979 AT INTERSECTION AND TIED OUT SINCE THERE ARE NO TIES OF RECORD.
