MONUMENT DESCRIPTION AND REMARKS: Highway department notes from 1941 indicate that the					
corner was placed on-line and 2636.5 feet from both center of Sections 12 & 13 and ties were established.					
A search for the Highway Department monument and ties was made, however all were gone. A monument					
was placed at the centerline of the east/west road and fence line to the south. By using this position,					
the corner falls approximately 2.7 feet east of a line drawn between the computed center of sections 12					
& 13. A distance of 2627.88 feet was measured to the center of Section 12 and a distance of 2627.76 feet					
was measured to the center of Section 13. Distances agree reasonably well with Highway Department					
information and the occupation was accepted as the best evidence for the corner location. New					
reference ties were established as noted below.
